**STATUS REPORT AND PROPOSED PROCEDURAL SCHEDULE**

Dear Judge Barnes:

Pursuant to the March 26, 2020 Order Granting Sunoco Pipeline, L.P.'S Partially Unopposed Motion to Stay Proceeding, SPLP provides this status update and proposed procedural schedule. The Order granted a 60 day stay and the parties were to confer regarding a procedural schedule within 30 days of entry of the Order. SPLP proposes the following procedural schedule, which simply moves the prior procedural dates back approximately 60 days, accounting for weekends, holidays, and availability:
