Dear Secretary Chiavetta:

This letter serves as an updated joint status report on behalf of West Penn Power Company (“West Penn”) and Mr. and Mrs. Magill. Counsel for West Penn has further conferred with Mrs. Magill to discuss their availability for the rescheduled evidentiary hearing. Mrs. Magill provided a response stating that she is not available at the end of May or in June 2020 and that hearing dates after July would be the best option for them. However, she did advise that to the extent that the Administrative Law Judge (“ALJ”) Watson intended to schedule the hearing for a June date, their preference is for June 30. Mrs. Magill also indicated she would separately be reaching out to ALJ Watson to advise of her conflicts.

That said, of the May dates provided by Mr. Pallas on behalf of ALJ Watson via an electronic mail message to the parties, counsel for the Company and its witnesses are only available on May 21, 2020. West Penn further affirms that counsel for West Penn and its witnesses remain available for the rescheduled evidentiary hearing on June 8, 9, 29 or 30, 2020.
