


Dear Ms. Roth,

⌘ NOTE 4 - When carrier provides a vehicle 20 to 24 feet in length, carrier will assess an additional \$10.00 per hour to the "vehicle and driver" hourly rate shown on the previous page. When the carrier provides a vehicle 26 feet or greater in length, carrier will assess an additional charge of \$20.00 per hour to the "vehicle & driver" hourly rate shown on the previous page.

▲ NOTE 5 - When in lieu of storage, shipment is held overnight on the vehicle, for the convenience of the shipper, an additional charge of \$150.00 (Non-Peak Season) and \$200.00 (Peak Season) will be assessed for each night in addition to all other applicable charges.
