Pursuant to 52 Pa. Code § 54.34(a), and the instructions set forth in the Pennsylvania Public Utility Commission's ("Commission") *Application for License Name Change-Checklist (EGS)(Revised May 28, 2019)(“Checklist”)*, Titan Gas, LLC dba Titan Gas and Power ("Titan Gas"), a licensed Pennsylvania EGS (Docket No. A-2016-2530633), hereby requests that the name on its EGS license be amended to reflect the addition of the following fictitious names:

Assuming the requested application for a name change is approved, the new name on the EGS license would be:

Titan Gas, LLC is not currently conducting any sales or marketing activity in the Commonwealth of Pennsylvania under either of these additional fictitious names. Our current plans include marketing to potential new customers under the "CleanSky Energy" name.

Our current plans also include transitioning customers served under the "Titan Gas and Power" name to the "CleanSky Energy" name. We do not have a date yet for this transition. However, pursuant to Item 3 in the Checklist, we will provide our existing customers with notice of the name change at least 30-days prior to the documented name change date. The notice will contain the new name and all relevant

contact information. We may make further refinements to this letter as we get closer to mailing. A copy of the current draft notice to customers is attached as Exhibit A

We will also alert the Commission's Bureau of Consumer Services at least 30-days prior to the documented name change date and provide the Consumer Services Bureau with a copy of the customer notification letter mailed to our customers so that the Commission's customer service representatives have the information they need if asked by customers about the change in names.

Pursuant to Checklist Item 4, we have served the application for a license name change (non-confidential documents only) on the five statutory agencies and all electric distribution companies in which Titan Gas is licensed to operate. Exhibit B contains our signed Certificate of Service as proof of service.


Pursuant to Checklist Item 5, the \$350 filing fee will be made by credit card with the filing.

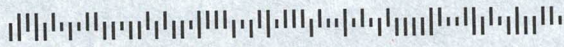
