Overfield Township's Opportunity to Comment on the Plan for Improvements to the Water System Currently Owned by Winola Water Company

Dear Chairman Ames:

Pennsylvania-American Water Company ("PAWC"), Winola Water Company ("WWC"), the Bureau of Investigation and Enforcement ("I&E") of the Pennsylvania Public Utility Commission ("PUC"), the Office of Consumer Advocate ("OCA") and Aqua Pennsylvania, Inc. ("Aqua") (collectively, the "Parties") are Parties to the above-referenced case before the PUC. The Parties are in the process of negotiating a settlement that will ask the PUC to approve PAWC's acquisition of the water system currently owned by WWC, subject to certain conditions.

The settlement will include a Plan for Improvements (including a timetable) by which PAWC will bring WWC's water system into compliance with applicable statutory and regulatory requirements. A copy of that Plan for Improvements is enclosed.

Overfield Township (the "Township") has the opportunity to submit comments to the PUC on the Plan for Improvements. In order to expedite the PUC's consideration of the settlement, PAWC requests that the Township indicate that it has reviewed the Plan for Improvements and has no objections. For your convenience, a form of a letter to that effect has been enclosed. If the Township has no objection to the Plan for Improvements, please sign the enclosed letter and return it to me for inclusion in the settlement petition that the Parties will file with the PUC.
