In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments transported distances of forty (40) miles and less between points in Pennsylvania.

Subject to Notes 1 to 7 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3 and 4.

Hourly rates apply from the time of arrival of vehicles and men at first point of origin (continues during loading, transportation from origin to destination, including any additional pickups or deliveries, and unloading at destination) until completion of unloading and dismissal of vehicles and men at destination.

Traveling charges cover traveling from the terminal to the first point of origin & traveling from final destination back to terminal.

NOTE 1 - Hourly rates (Columns 2 and 3) computed in quarter-hour periods; fractions of one quarter-hour considered one-quarter hour.

▲ NOTE 2 - Applicable travel charge will be determined based on the combined distance from terminal to first point of origin and from final destination to terminal:

<u>Over</u>	<u>Not Over</u>	
0	15	One-half (1/2) hour
15	30	One (1) hour
30	40	One & one-half (1 1/2) hour

▲ NOTE 3 - Minimum Transportation Charges: And Day (any hour): Two (2) hours at rates named in Columns 2 and 3 plus applicable travel charge.

▲ NOTE 4 - Waiver of minimum charges - carrier convenience: Carrier shall not assess a minimum charge (number of hours) whenever a move requires less than the minimum number of hours filed AND said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on actual time to complete the move plus applicable travel charge.

▲ NOTE 5 - When an additional pickup or delivery is part of the shipment, carrier will assess a flat handling charge of \$25.00 in addition to the applicable hourly rates published herein.

▲ NOTE 6 - When a shipment is held over, carrier will assess a flat handling charge of \$50.00 per night in addition to the applicable hourly rates published herein. The applicable hourly rate will begin at the time of leaving the carrier's terminal for delivery.

▲ NOTE 7 - When a shipper requests labor only, carrier will assess a flat fee of \$40.00 per man with a three (3) hours minimum.
