**COMPLAINANT’S REQUEST FOR INFORMATION**

In order to respond to Public Utility Commission Secretary Chiavetta’s letter dated 4 June 2020, which concerns filing of Exceptions, Complainant Dr. Deborah A. Redman needs the following information:

- (1) the date the Exceptions must be filed with the Commission. In other words, 20 days from June 4 is when? (Complainant asks because Attorney Morris has forcefully lectured her in the past that the Commission uses consecutive days, counts the date of receipt and all holidays.)
- (2) the names, titles, and functions of the 4 Respondent witnesses that appeared with Attorney Morris at the 21 May 2020, hearing that Judge Long held with the Respondents’ attorney, Margaret Morris (per Initial Order, p. 4, par. 3).
- (3) if available, a copy of a transcript of the May 21 hearing with Judge Long and Attorney Morris and her 4 witnesses
- (4) a copy of the docket sheet in this case
- (5) an explanation how Complainant is to file photos. Complainant has photos from a 35-mm camera (whose photos are higher quality and much more difficult to alter

than digital photos). No CD is provided and no scanner available, so uploading photos is probably impossible. Complainant suggests she be allowed to mail in her filings with photos. She does not have COVID-19 or its symptoms and has to be scrupulously clean always (not just in pandemics) because she is chronically ill and immune compromised.

Complainant thanks the Commission in advance for a prompt response.
