The parties in this case have reached the below proposed stipulations. The parties respectfully ask that the Court accept these stipulations into the record in this matter:

1. The balance of \$4,432.01, which is reflected in PGW Exhibit 3, page 4 was paid by Gerald Jones ("Mr. Jones") on May 19, 2020.
2. There is currently no outstanding balance at 235 S. Ithan Street, Philadelphia, PA ("Service Address").
3. Gas service to the Service Address was restored by PGW on June 4, 2020.
4. Gas service at the Service Address is now in the name of Mr. Jones.
5. Mr. Jones does not have gas service from PGW at any address other than the Service Address.
6. Mr. Jones is still disputing liability for the balance of \$4,432.01, which he has since paid and wishes to amend the relief sought in the Complaint to include a request for a refund in the amount of \$4,432.01.
7. PGW does not object to Mr. Jones' amending the relief sought in the Complaint to include a request for a refund.
