Dear Secretary Chiavetta:

In accordance with the Interim Order issued on June 10, 2020 in the above-referenced matter, this letter serves as a status report on behalf of Pennsylvania Electric Company (“Penelec”). Ms. Shedlock has failed to provide notification of her expert and factual witnesses. Penelec timely provided notice of its expert and factual witnesses and avers that discovery between the parties is now complete.<sup>1</sup>

As such, Penelec anticipates that Ms. Shedlock will not be presenting testimony in this matter or, if she does, it will be limited to her own factual testimony and that of her husband at the time of any evidentiary hearing. Therefore, Met-Ed anticipates that it will only need to present one witness, Mr. John Ahr, in order to rebut any factual testimony offered at that time.

Counsel for Penelec has conferred with Ms. Shedlock regarding the scheduling of a telephonic evidentiary hearing. The parties are available for a hearing in September 2020 as follows: September 1, 2, 4, 14, and 16-18, 2020. Further, Ms. Shedlock indicated to counsel for Penelec that she works nights and is requesting a delayed start of 11:00 a.m. for any evidentiary hearing scheduled. Penelec does not oppose Ms. Shedlock’s request.
