This is in response to Docket No. C-2020-3018863, from the Pennsylvania Public Utility Commission, dated March 13, 2020.


I cancelled the Authority for Butters Trucking, LLC as of 12/31/19 as Butters Trucking, LLC is no longer in business as of 12/31/19.


UNIFORM MOTOR CARRIER BODILY INJURY AND PROPERTY DAMAGE LIABILITY INSURANCE ENDORSEMENT
