On May 21, 2020, Metropolitan Edison Company, Pennsylvania Electric Company, and Pennsylvania Power Company (collectively, “FirstEnergy” or the “Companies”) served their Rebuttal Testimony, which included Proprietary and Non-Proprietary versions of FirstEnergy Statement No. 1-R, the Rebuttal Testimony of Stephen F.
