

In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 51 for the above carrier, the following assessorial rates shall apply for shipments traveling between points in Pennsylvania and transported distances over forty (40) miles.

▲◆ ITEM 110 and Item 115 - Containers, Packing, & Unpacking

Packing and unpacking to be performed using Schedule E rates shall apply for Non-Peak Season and Schedule F rates shall apply for Peak Season. Refer to Page 58 and Page 58-B of Freight PA. P.U.C. No. 51 (Tristate 51-W) for definition of Non-Peak Season and Peak Season. Regular time and overtime charges will apply as applicable.
