**NOTICE OF COMPLAINT
BEFORE THE PUBLIC UTILITIES COMMISSION**

The City of Uniontown, Fayette County, Pennsylvania, has filed a Complaint with the Pennsylvania Public Utilities Commission regarding the railroad crossing of Southwest Pennsylvania Railroad located across, through, and within North Beeson Avenue in the City of Uniontown beginning at the entryway of the railroad line at Library Place, passing across and through the various lanes of Beeson Avenue, to its exit point at West Penn Street. The City's requests abolition and removal of such crossing in its Complaint. The City's Complaint has been assigned Docket No. C-2020-3017829 and is related to prior abolition proceedings assigned Docket No. A-2019-3009552. A pre-hearing telephonic conference is scheduled for July 15, 2020, at 2:00 p.m.
