On June 22, 2020, the Pennsylvania Public Utility Commission sent Breakerbox, LLC a letter requesting two items regarding their Application. Please see below for each item and response.

1. Reference Application, Section 7.b, Financial Fitness – Applicant provided minimal documentation to demonstrate financial fitness. Please provide additional financial fitness documentation that may include two recent consecutive years of financial statements, two recent consecutive years of income tax filings, or Parental/Affiliate Guarantee showing ongoing operational funding commitment, signed by both parties and three recent consecutive months of bank statements.

Breakerbox, LLC was formed on August 26, 2019 and does not have two years of information. Breakerbox, LLC is a subsidiary of Exelon Generation Company (“ExGen”), which is a subsidiary of Exelon Corporation (“Exelon”). Exelon is a Fortune 100 company and had 2019 revenue of \$34 billion. 
In addition, enclosed is a letter from ExGen that it will maintain appropriate credit facilities for Breakerbox, LLC in Pennsylvania.

2. Reference Application, Section 7.f, Taxation – Applicant provided an incorrect Corporate Box Number instead of a Revenue ID Number on its Tax Certification Statement. Any company registered in the Commonwealth of Pennsylvania after March 2013 must contact the Pennsylvania Department of Revenue for its 10-digit Revenue ID Number. Please submit a corrected Tax Certification Statement.

Breakerbox, LLC has submitted a request to the Pennsylvania Department of Revenue. We have not received the information yet to submit a corrected Tax Certification Statement. We kindly request an extension of time to submit this statement.
