Dear Secretary Chiavetta:

The purpose of this letter is to advise the Pennsylvania Public Utility Commission (“Commission”) that Ambit Northeast, LLC (“Ambit Energy”) and Vistra Corp (“Vistra”) have entered into an agreement for the acquisition by Vistra’s subsidiary, Dynegy Energy Services East, LLC (“Dynegy”), of certain customer accounts of Ambit Energy in the Commonwealth of Pennsylvania. Pursuant to the agreement, Ambit Energy will assign to Dynegy approximately [REDACTED] contracts for the provision of electric generation services to Pennsylvania commercial customers. Approximately [REDACTED] Pennsylvania customers will remain with Ambit Energy after the customer transfer. Ambit Energy’s license docket number is A-2010-2190276. Dynegy’s license docket number is A-110153.

A 30-day notice is being sent to the impacted customers to inform them of the contract transfer. A copy of the template notice is provided in **confidential** Appendix A. The notice includes the following information:

- The transfer of service from Ambit Energy to Dynegy will be initiated after the expiration of the 30-day notice period and that the effective date of the transfer is expected to occur as of the meter read date after [REDACTED]
- An explanation of the reason for the contract assignment




