My name is Michael Kogan, I was the president and the owner of Blue And White Transportation Inc.

The reason that I receive these letters complains against my business is I believe because of that PUC department has never received my request to permanently close my firm, including termination of my PUC certificate A number - A-6421831.

An abandonment letter / form of service for a small passenger carrier, to discontinue service in whole part between points in the Commonwealth of Pennsylvania has been filled out and mailed to PUC a while ago, I did exactly as I was instructed by the staff of PUC, that in order to request a discontinue of service and to close my business I must fill out a form sign it and mail it to the PUC, which I did a few weeks before the beginning of the war (corona virus), I was also informed about the fine of \$500.00 that I may expect if I would not do that.


Unfortunately, I do not recall weather I mailed the abandonment letter form as a regular letter or as a certified letter.

I was the president and the owner of a business - non emergency Medical Transportation - a Paratransit up to 4 passengers, not a bus, it was a non-life sustaining business. I also had commercial auto liability insurance from First Insurance Funding and it was \$1,044.98 a month, which I also requested to cancel my policy and I was awaiting a month for that, I received the license to operate on July 2, 2019, and commercial auto liability was finally active on September, but I never found and signed any contracts / jobs, that is why

I decided to permanently close it, it is so sad , so badly sad as I never made any jobs, I did not have a chance to earn a penny.

Do I need to do the abandonment form again? , with a tears on my eyes I am begging you please kindly do not make me to suffer another expense the fine \$500.00, me and my family currently trying to survive and help each other and that would be just another curb to be hit by.
