To Whom It May Concern:

This letter serves as notice to the Pennsylvania Public Utility Commission ("PUC") that Plymouth Rock Energy LLC ("Licensee") has changed its legal name to ENGIE Power & Gas LLC, resulting in a non-material change to Licensee's license information. Also, as a result of an internal corporate reorganization, Licensee is now a direct wholly-owned subsidiary of ENGIE Resources LLC (whereas prior it was indirectly owned by ENGIE Resources through two internal holding companies). Thus, ENGIE Resources' ultimate ownership of Licensee has not changed.




