### **NOTICE**

The application of rates proposed in Tariff Gas Pa. P.U.C. No. 9 filed to become effective June 23, 2020 was suspended until January 23, 2021, pursuant to the Pennsylvania Public Utility Commission's Order entered on May 21, 2020 at Docket No. R-2020-3018835. Supplement No. 315 hereby further voluntarily suspends the application of rates until February 25, 2021, subject to the condition that, at the time the compliance filing is approved by the Commission, Columbia Gas of Pennsylvania, Inc., will retroactively bill the revenues lost at the final approved rates for the period from the end of the statutory suspension period (January 23, 2021) through the date the Commission makes its approved rates effective by approving the requisite compliance filing. Presently effective rates set forth in Tariff Gas Pa. P.U.C. No. 9 and supplements thereto will continue in effect until amended in the manner set forth above.

Issued in compliance with 66 Pa. C.S. §1308(d), the Order of the Pennsylvania Public Utility Commission entered May 21, 2020 at Docket No. R-2020-3018835, and the Commission approved Motion of Vice Chairman David W. Sweet made at Public Meeting on August 6, 2020, which adopted January 23, 2021 as the effective date of new rates.


