- b. News has been circulating regarding NRG Energy Inc acquiring Direct Energy. Please explain if this acquisition will affect the organizational chart or any details in this application.

Yes; recently the news was made public in the industry that NRG Energy Inc. (“NRG”) has entered into an agreement to acquire Direct Energy - the North American operations of UK-based Centrica plc (“Centrica”). The proposed acquisition by NRG has not yet completed and remains subject to customary closing conditions including certain necessary regulatory approvals as well as Centrica shareholder approval. We anticipate that the acquisition will complete at the end of this year or early 2021. Until such time Direct Energy will operate Bounce and its other businesses in the ordinary course of business as it is required and expected to do. Upon closing of the acquisition, NRG will become the ultimate parent company owner of Direct Energy and its legal entity subsidiaries.

Since no additional detailed plans have been provided at this time, we are unable to predict the impact of the proposed acquisition on the other details in the application.

Please specify if Bounce Energy, Inc. will only be providing broker/marketer services for one supplier or if its broker/marketer services will be provided to multiple EGS suppliers.


Bounce Energy, Inc. will provide services to multiple electric generation suppliers.
