Re: Verizon vs. Tenny C2020-3016895

Dear Ms. Chiavetta,

I respond to the motion to dismiss dated this date, filed by Susan Paiva.

I request that this motion be denied, and that I be given my day in court via telephonic hearing on August 12. To respond to the Complaint:

1-Tenny will be represented by an attorney on the day of the hearing-and will file prior. I was told this would be acceptable. My attorney is currently winning a massive lawsuit against Verizon for tortuous interference in our business, illegal cutoff of phone service and massive overcharging. The case has been won by Tenny and damage hearings are currently being conducted. She will file prior to 8/12/20.

2-Yes, authority was revoked due to no activity. But why? Because Verizon illegally turned off Tenny's telephone service for no reason in 2018! This has already been litigated and won. Verizon was ordered to restore service fully in early 2019 and the phones are operating again. We have written the State of Pennsylvania to reinstate our active status-the office is closed and has not gotten to my letter, I suppose. A dastardly act on the part of Verizon.

3-No pre-hearing conference should be held. I have numerous letters back and forth between myself and Ms. Pavia. Another conference will do nothing. My lawyer believes a phone hearing of no more than one-half hour will present all of the facts, which are quite simple. This is a ruse by Ms. Paiva and Verizon to ramp up legal fees to our company which we cannot afford as you know, in needless conferencing of a very simple matter.

Please dismiss the legal complaint. Until this matter reaches the telephone hearing, we are not required to have an attorney, which Ms. Paiva hopes to undo and cause us thousands in unnecessary legal fees.


