Attached are updates for 326th Revised Page 2, 118th Revised Page 2-B, 8th Revised Page 70-J, 4th Revised Page 70-K, 1st Revised Page 70-K-1, and 6th Revised Page 70-L for Movin' Murdy, Inc. (PA PUC #A-00119720) in North Versailles PA. This filing is an INCREASE in hourly rates (moves 40 miles & under - Non-Peak and Peak), a CHANGE in the application of the travel time charge, an INCREASE in the additional charge for pianos and safes, an INCREASE in intrastate transportation rates (moves 41 miles & over – Non-Peak and Peak), and an increase in container charges. Also, the verbiage at the top of the pages has been updated to show their operating authority as between points in Pennsylvania per changes made by the PUC granting movers statewide operating authority in May 2015.
