I am writing you today for purposes of reconsideration on your Final Order (M-2020-3015227) entered August 25, 2020 in regard to the cancellation of JMI Consultants, LLC's ("JMI") Electric Generation Supplier License (No. A-2019-3009003) due to Expired Financial Security.

As a first consideration, JMI Consultants is able to provide the Commission with its Petition for Reconsideration a Continuation Certificate for Bond No. 98-CH-K658-7 in the sum of Ten-Thousand-Dollars (\$10,000) on behalf of JMI Consultants LLC in favor of the Pennsylvania Public Utility Commission dated March 18, 2020 and covering the Continuation Period through March 30, 2021. A copy of the Continuation Certificate is included in JMI's submission. The Continuation Certificate is valid for JMI's renewal period.

As a second consideration, JMI is unable to locate the electronic notice of the Tentative Order from June 18, 2020 mentioned in your Final Order received on August 25, 2020. JMI also did not receive a hard copy of the Tentative Order from June 18, 2020 at its offices. Had JMI received either the electronic notification or paper copy notification of the Commission's Tentative Order, we would have immediately sent the original copy of JMI's Continuation Certificate for Bond No. 98-CH-K658-7 to the Secretary's attention.

We also recognize the adjustments being made both within the Commission and among all organizations conducting business within the Commonwealth of Pennsylvania amidst the COVID-19 pandemic and ask for reconsideration based on this fact. We understand our requirement to furnish a copy of any renewals or Continuation Certificates for the EGS Surety requirements and have made procedural changes to ensure the Commission is in prompt receipt of any required documentation going forward.

We look forward to our continued service within the Commonwealth of Pennsylvania.
