Please accept this monthly status update on behalf of Philadelphia Gas Works (“PGW”) regarding PGW’s Customer Responsibility Program (“CRP”) energy burden changes and consumption limit change Pilot Program, as required by Ordering Paragraph 7 of the Order entered March 26, 2020 (“Order”). Currently, PGW expects to be able to complete the consumption limit enhancement by September 30, but has encountered some issues that may create a short delay in implementation.
