

Jobs that must start after 4:00PM or before 5:30AM, at the customer's request, are considered "off-hours" moves and the following additional charges will apply:

Jobs estimated to be less than 4 hours	\$50.00 per man per job
Jobs estimated to be 4-6 hours	\$75.00 per man per job
Jobs estimated to be greater than 6 hours	\$100.00 per man per job

NOTE AA - Travel time charge is based on the combined distance from carrier's terminal to the first point of origin and from final destination back to the carrier's terminal at the applicable rates shown above per the mileage chart below.
