RULES AND REGULATIONS

RESERVATIONS:

ADVANCE RESERVATIONS MUST BE MADE PRIOR TO THE SERVICE BEING RENDERED. ADVANCE RESERVATION REQUEST MUST BE MADE NO LATER THAN 24 (TWENTY FOUR) HOURS PRIOR TO THE TIME OF NEED ON THE CALENDAR DATE OF SERVICE FOR MONDAY THROUGH FRIDAY SERVICE. ADVANCE RESERVATION REQUEST MUST BE MADE NO LATER THAN 48 (FORTY EIGHT) HOURS IN ADVANCE OF THE CALENDAR DATE OF SERVICE FOR SATURDAY SERVICE.

MILEAGE:

FLAT MILEAGE RATE, CHARGES BEGIN AND END FROM THE CUSTOMER'S POINT OF PICK UP TO THE CUSTOMER'S POINT OF DROP OFF.

AVAILABLE HOURS OF SERVICE:

PARATRANSIT SERVICES WILL BE AVAILABLE BETWEEN THE HOURS OF 6:00 AM AND 9:00 PM, MONDAY THROUGH SATURDAY, BY AN ADVANCE RESERVATION REQUEST, EXCLUDING HOLIDAYS.

ADDITIONAL EXPENSES:

ANY ADDITIONAL EXPENSES REQUIRED BY OR INCURRED AT THE REQUEST OF EITHER THE PASSENGER OR THE CARRIER, INCLUDING BUT NOT LIMITED TO, BRIDGE AND OR HIGHWAY TOLLS, PARKING CHARGES, DRIVER EXPENSE, ENTRANCE FEES, ESCORT OR ATTENDANT FEE (IF AN ESCORT OR ATTENDANT OF THE CARRIER IS REQUIRED TO REMAIN WITH THE PASSENGER) SHALL BE ADDED TO THE CHARGE FOR THE TRIP.

DEPOSIT RULE:

CARRIER REQUIRES A DEPOSIT OF NOT MORE THAN 20% OF THE QUOTED CHARTER PRICE. FORFEITURE OF DEPOSITS IS WITHIN THE FOLLOWING LIMITATIONS:

- 1) FORFEITURE OF NOT MORE THAN 50% OF THE DEPOSIT IF THE CHARTER IS CANCELLED BY THE CUSTOMER MORE THAN 15 (FIFTEEN) BUT LESS THAN 30 (THIRTY) DAYS PRIOR TO THE DATE THE TRANSPORTATION WAS TO DEPART, AND
- 2) FORFEITURE OF NOT MORE THAN THE TOTAL AMOUNT OF THE DEPOSIT IF THE CANCELLATION OCCURS WITH 15 (FIFTEEN) DAYS PRIOR TO THE DATE THE TRANSPORTATION WAS TO DEPART.

AFTER 2 HOURS-ADDITIONAL \$5.00 PER 30 MINUTE INTERVALS, OR ANY FRACTION THEREOF.

WAIT TIME AT ORIGIN (PICK-UP):

THERE WILL BE NO CHARGE FOR THE FIRST 5 (FIVE) MINUTES THAT THE CARRIER MUST WAIT FOR A CUSTOMER BEYOND THE SCHEDULED PICK-UP TIME. ANY ADDITIONAL WAITING TIME WILL BE CHARGED AT THE RATE OF \$5.00 FOR EACH 15 (FIFTEEN) MINUTES OR ANY FRACTION THEREOF.

WAIT TIME DURING TRIP:

IF CARRIER IS REQUESTED TO WAIT FOR A CUSTOMER AT A DESTINATION OR DURING THE TRIP, THERE WILL BE AN ADDITIONAL WAITING TIME CHARGE OF \$8.00 PER 15 (FIFTEEN) MINUTES OR ANY FRACTION THEREOF.
