National Fuel Gas Distribution Corporation ("NFGDC") is aware Power Marketing Group, LLC (PMG) has filed an application with the Pennsylvania Public Utility Commission to supply natural gas service to the public in Pennsylvania and specifically within the service territory of NFGDC.

As you know, in making such an application, PMG must furnish acceptable security to each utility where PMG will do business. As such, under its tariff, NFGDC could require PMG to provide a bond or other financial security instrument in an amount that NFGDC determines to be appropriate.


