However, to date, there has been no further communication from Ms. Giesler.


Ms. Giesler also informed Complainant that she would submit a joint status report. By September 4, 2020. At present there is no confirmed date set. for the hearing.



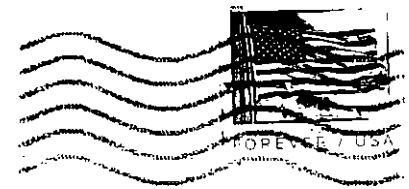
