Dear Secretary Chiavetta:

On September 11, 2020, Noreen McCarthy (“Complainant”) filed additional proposed corrections to the hearing transcript in accordance with the Interim Order issued on August 21, 2020.

Upon review of the Complainant’s proposed corrections, Metropolitan Edison Company (“Met-Ed” or the “Company”) does not have any substantive issues with the corrections. However, the Company notes that each of the Complainant’s citations incorrectly references the page before the actual page where the statements appear. For example, when the Complainant cites page 23 of the transcript, the referenced quote actually appears on page 24.

Furthermore, Met-Ed observes the following:

- On page 6 of the Complainant’s Errata Sheet, where she references how the transcript incorrectly states “Ms. McCarthy” on pages 32 and 33 of the transcript (in actuality, pages 33 and 34 of the transcript, due to the Complainant’s page numbering issue mentioned previously), Met-Ed agrees and notes that the transcript should read “Ms. Giesler” in those instances.
- On pages 14 and 15 of the Complainant’s Errata Sheet, where she references how the transcript incorrectly states “Mr. Zimmerman” on pages 68 and 78 of the transcript (in actuality, pages 69 and 79 of the transcript, due to the Complainant’s page numbering issue mentioned previously), Met-Ed agrees and notes that the transcript should read “Mr. Renner” in those instances.
