This is the first that I have heard of this data request for Docket No. A-2020-3020804. We did not receive the letter from the commission, only the email from you today. However, here is the information that you are requesting.

1) Throughout the EGS application there were typographical errors while referencing the applicant. The correct name of the applicant is:

CCI INDUSTRIES, Inc. d/b/a CommonWealth Utilities

2) Reference Application, Section 4.a, Present Operations: Applicant should have marked X next to "other" and provided the following explanation:

CCI Industries, Inc. d/b/a Common Wealth Utilities inadvertently marked Broker/Marketer when it should have marked "other".

The company is a marketer/marketing services consultant/energy consultant of electric services and is under contract to a <u>single licensed Electric Supplier</u> and falls within the scope of the definition set-forth below found on page 3 of the Public Utility Commission EGS application.

Guttman Energy was acquired by Suez Energy in 2016 which eventually became Engie. The terms of the Guttman Energy contract

remained in place and CCI Industries, Inc. d/b/a CommonWealth Utilities represented Engie exclusively to present day. CCI Industries, Inc. d/b/a CommonWealth Utilities only Electricity Supplier is Engie.

3) Pennsylvania Power Company (Penn Power) Certificate of Service (included). Please note that section 6, page 10 (proof of Service) of the EGS application does not state or omits that Pennsylvania Power Company (Penn Power) is to be served notice.


