ORDINANCE NO. 2012-______

AN ORDINANCE AMENDING CHAPTER 18, SECTION 205.1 AND 205.2 OF THE VALLEY TOWNSHIP CODE OF ORDINANCES BY INCREASING THE QUARTERLY SEWER RENT FOR PROPERTIES SERVED BY THE VALLEY TOWNSHIP SEWER SYSTEM AND FOR PROPERTIES SERVED BY BOTH THE VALLEY TOWNSHIP SEWER SYSTEM AND THE WATER SYSTEM OF EITHER VALLEY TOWNSHIP OR THE PENNSYLVANIA AMERICAN WATER COMPANY

BE IT ENACTED AND ORDAINED, this 27th day of December, 2012, by the Board of Supervisors of Valley Township, Chester County, Pennsylvania, that Chapter 18, Part 2 of the Valley Code of Ordinances be amended as follows:

<u>Section 1</u>. That Section 205.1, be amended by deleting the words "one hundred seventy-six dollars (\$176.00) per quarter," and substituting in place thereof the words "two hundred twenty dollars (\$220.00) per quarter."

Section 2. That Section 205.2, be amended by deleting the words "one hundred forty-three dollars (\$143.00) for the first ten thousand (10,000) gallons of metered water usage, and eight and 60/100 dollars (\$8.60) for each additional one thousand (1,000) gallons, or fraction thereof," and substituting in place thereof the words "one hundred seventy-nine dollars (\$179.00) for the first ten thousand (10,000) gallons of metered water usage, and eleven and 20/100 dollars (\$11.20) for each additional one thousand (1,000) gallons or fraction thereof."

<u>Section 3</u>. This Ordinance shall be effective January 1, 2013.
