▲ NOTE 5 - A deposit of \$250.00 is required on all moves. Deposit will be refunded if move is cancelled or rescheduled 10 days prior to the move date. If notice of cancellation is less than 10 days prior to the move date, deposit is non-refundable.

▲ NOTE 6 - If a piano or safe are included in the shipment, a handling fee of \$100.00 per item will apply in addition to hourly charges. A special handling fee of \$100.00 will apply for Grandfather Clocks, Arcade and Pinball machines, and Peloton or similar exercise equipment in addition to hourly charges. Handling fee in addition to hourly charges when pool table is included in shipment is \$300.00.

▲ NOTE 7 - If shipment needs to be held overnight, for the convenience of the shipper, a charge of \$200.00 per vehicle per night will apply for vehicle(s) less than 24 feet in length - for vehicle(s) 24 feet or 26 feet in length, charge is \$350.00 per vehicle per night.
