AMENDMENT TO  
AGREEMENT OF SALE AND SERVICE

This Agreement, dated as of the Twelfth day of February, 1985, between the Borough of Upland ("Borough") and Delaware County Regional Water Quality Control Authority ("DELCORA") is intended to amend a certain Agreement of Sale and Service entered into between the parties hereto as of the 22nd day of July, 19~~75~~<sup>7</sup>, and as amended as of the 18th day of January, 1983.

WITNESSETH:

WHEREAS, the parties hereto entered into a certain Agreement of Sale and Service dated July 22, 1975, and amended January 18, 1983; and

WHEREAS, compliance with USEPA Municipal Industrial Pretreatment Program Regulations has dictated the necessity of certain modifications to that Agreement.

NOW, THEREFORE, the parties hereto, intending to be legally bound hereby agree as follows:

1. All terms and conditions of the Agreement of Sale and Service dated July 22, 1975, and amended January 18, 1983, between the parties hereto shall remain in full force and effect as modified or amended by this Agreement.

2. Sewer Use. Borough agrees to comply with DELCORA's regulations on sewer use, to fully cooperate with DELCORA in the administration and

enforcement of such regulations, and to adopt such ordinances as may be reasonably required by DELCORA to facilitate such control, administration, and enforcement.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed by their respective duly authorized officers of the date first stated.
