

RESTRICTIVE AMENDMENT

TO THE HONORABLE JOEL H. CHESKIS, ADMINISTRATIVE LAW JUDGE:

Reading Checker Cabs, LLC (hereinafter "Applicant"), Yellow Cab Company of Lebanon, Inc., and Super Cab, Inc. (hereinafter collectively "Protestants"), jointly file this Restrictive Amendment and Stipulation as follows:

- 1. The parties hereto agree and stipulate to eliminate the ability of Applicant to provide call and demand (taxi) service to, from, and between points in the County of Lebanon.**
- 2. In furtherance of this objective, the parties request that the above captioned application be amended to clearly identify and specify the territory requested so that the authority sought shall read as follows:**

To transport, as a common carrier, persons in call or demand (taxi) service between points in Berks, Schuylkill, Dauphin, and Luzerne Counties.

- 3. Based upon the condition set forth in Paragraphs 1 and 2 and further conditioned upon the acceptance of this Restrictive Amendment by Your Honor and the Pennsylvania Public Utility Commission (the "Commission") without amendment, and the issuance of any order being consistent herewith, Protestants agree to withdraw their protests to the Application as**


amended. Notwithstanding the above, Protestants desire to remain a party of record so as to receive copies of any orders issued by Your Honor and the Commission in this proceeding.

4. It is the policy of the Commission to encourage settlements in any contested proceeding. This restrictive amendment is in the public interest in that it resolves numerous issues to be raised by Protestants while providing the Applicant with the ability to provide call and demand service in a vast service territory.

5. If the Restrictive Amendment is not accepted by the Commission, the parties agree that further hearings shall be held to permit the parties to present evidence in support and opposition to the Application.




