In compliance with the Secretarial Letter issued in the above-referenced proceeding on September 11, 2020 ("Secretarial Letter"), this correspondence is to inform the Pennsylvania Public Utility Commission ("Commission") that Pennsylvania-American Water Company ("PAWC") has complied with the Secretarial Letter conditions by completing the following:

On October 13, 2020, PAWC filed a Certificate of Service with the Commission that copies of the Application and Amended Application had been served on the parties referenced in the Secretarial Letter.

In Compliance with the Secretarial Letter and in compliance with the Final Supplemental Implementation Order entered at Docket No. M-2016-2543193, PAWC advised the Commission on September 21, 2020, that it was beginning to provide individualized notices of the proposed acquisition to all potentially affected PAWC water and wastewater division customers. PAWC has completed providing such individualized customer notice. PAWC has also provided concurrent notice to all current Royersford Borough wastewater customers.

PAWC filed proof of publication of the notice of the proposed acquisition in the Times Herald with the Commission on October 9, 2020.

Enclosed is a Verification signed by Bernard Grundusky confirming satisfaction of the conditions established in the Secretarial Letter by PAWC.

PAWC respectfully asks that the Commission, on November 9, 2020, or promptly thereafter, accept the Application, as amended, for official filing purposes via Secretarial Letter and publish notice of the Application in the November 21, 2020, edition of the Pennsylvania Bulletin with a December 7, 2020 protest and intervention due date, consistent with the September 29, 2020 Secretarial Letter.
