

Attached are updates for 337th Revised Page 2, 89th Revised Page 6, 6th Revised Page 28, 4th Revised Page 28-A, and Original Page 28-A-1 for Mak Movers & Storage LLC t/a New Horizon Movers & Storage (PA PUC #A-8916906) in Souderton PA. This filing is for an INCREASE in local hourly rates and a CHANGE in the application of Travel Time charges. Also CHANGED packing labor by the hour to apply to both local & intrastate moves. ADDED "t/a New Horizon Movers & Storage" to the name and CHANGED location to Souderton PA as company is listed in the PUC mover's directory. CHANGED the scope of authority at the top of each page to show "shipments transported between points in Pennsylvania" as Mak Movers & Storage LLC t/a New Horizon Movers & Storage was "grandfathered" into statewide authority when statewide authority was granted to movers by the PUC in May 2015.
