

▲ NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays (any hour): four (4) hours at rates named in Column 2 plus applicable travel charge. Monday through Saturday (any hour): three (3) hours at rates named in Columns 3 and 4 plus applicable travel charge.

NOTE 2 - BULKY ITEM: \$125.00 surcharge for pianos, safes, exercise equipment, machinery, etc. weighing in excess of 200 pounds.

NOTE 3 - LAYOVER/SORAGE-IN-TRANSIT: Holding furniture on truck at shipper's request will be allowable for up to three (3) nights. If items cannot be delivered within the time period, shipment will be moved to storage at all prevailing rates. Cost for overnight holding is \$125.00 per night plus applicable travel time on delivery date.

▲ NOTE 4 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour (15 minutes) periods; fractions of one-quarter hour (15 minutes) considered as one-quarter hour (15 minutes).

▲ NOTE AA - A flat charge based on one hour at the applicable transportation rates shown in Columns 2, 3 and 4 will apply if the road miles from the carrier's terminal to both the first point of origin and from the final point of destination back to the carrier's terminal are 20 miles or less. Should the combined road miles from carrier's terminal to first point of origin and from final destination back to carrier's terminal be greater than 20 miles, a travel charge based on 15 minutes for each additional 10 miles will apply.
