

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour (15 minutes) periods; fractions of one-quarter hour (15 minutes) considered as one-quarter hour (15 minutes).

NOTE 4 - Minimum Transportation Charge: Any Day (any hour): 3 hours at rates named in Columns 2, 3 and 4 plus applicable travel charge.

NOTE 5 - When a piano is included in the shipment, a handling fee per piano in addition to the applicable hourly charges will apply:

**Spinet - \$100.00    Upright - \$150.00    Baby Grand - \$250.00**

NOTE 6 - When a gun safe or large tool cabinet/chest is included in the shipment, a handling fee per item in addition to the applicable charges will apply: up to 300 pounds - \$200.00    301 pounds to 500 pounds - \$300.00

Handling charge for all other bulky items: up to 500 pounds - \$300.00

Exercise equipment must be dismantled and reassembled by the customer or other vendor arranged by the customer.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage.

0 -10 miles	1/2 hour
11 - 20 miles	1 hour
21 - 30 miles	1 1/2 hours
31 - 40 miles	2 hours

For mileage in excess of 40 miles, a travel time charge of 1/2 hour will be assessed for each additional 10 miles.
