

RESOLUTION NO. 2011 - 13

WHEREAS, Valley Township is a Township of the Second Class, organized and existing under the Second Class Township Code, 53 P.S. §65101, et. seq.; and

WHEREAS, Valley Township owns and operates a water system, supplying certain areas within the said Township with water, some of which is provided by wells within the municipal boundaries and the remainder of which is purchased in bulk from Pennsylvania American Water Company; and

WHEREAS, an engineering study has been performed by Pennoni Associates, Inc., the Township Engineer, which study has shown that an increase in the rates charged customers is necessary to insure the fiscal soundness of the water system's operation.

NOW, be it **RESOLVED** this 20th day of December, 2011, by the Board of Supervisors of Valley Township, Chester County, Pennsylvania, that the following water rate increases are hereby approved, to be effective with the first quarter, 2012, (commencing January 1, 2012):

1. The quarterly service rate is hereby increased from eighty and 33/100 dollars per quarter to eighty-four and 35/100 dollars per quarter.
2. The use rate per thousand (1000) gallons of water, which rate is charged after the use of the initial 10,000 gallons of water in a quarter, is hereby increased from eight and 03/100 dollars per thousand (1000) gallons of water to eight and 40/100 dollars per thousand gallons of water..

**A RESOLUTION OF VALLEY TOWNSHIP BOARD
AUTHORIZING THE EXECUTION AND FILING OF
PETITIONS FOR DECLARATORY ORDER WITH THE
PENNSYLVANIA PUBLIC UTILITY COMMISSION.**

WHEREAS, Valley Township owns and operates a (1) sanitary sewer collection and treatment system (“Wastewater System”) and (2) water treatment and distribution system (“Water System”); and

WHEREAS, in addition to the Sewer System and Water System customers who are located within the Valley Township municipal boundary, 22 additional water customers from adjacently located West Caln Township and East Fallowfield Township are tied into and being served by the Water System (“Outside Water Customers”) and 30 additional wastewater customers from adjacently located West Caln Township and East Fallowfield Township are tied into and being served by the Wastewater System “Outside Wastewater Customers” and collectively with the Outside Water Customers, “Outside Customers”); and

WHEREAS, it is necessary, reasonable and fiscally prudent to charge the Outside Customers the same rate as Valley Township customers.

NOW THEREFORE, BE IT AND IT IS HEREBY RESOLVED, by the Township of Valley Board of Supervisors as follows:

1. Valley shall charge the Outside Customers the same rates charged for Valley customers; affirms and confirms that Valley shall not expand the Water System and Wastewater System services to any other property located outside of Valley Township.
2. The Chair of the Board is hereby authorized to execute and cause to be filed a Petitions For Declaratory Order (“Petitions”) with the Pennsylvania Public Utility Commission


("Commission") seeking to have the Commission declare that Outside Customers shall not be subject to the Commission's jurisdiction, stating that Valley shall only charge the Outside Customers the same rates charged for Valley customers; and further limiting the Petition to only those Outside Customers, and affirming that there will be no additional expansion of the Water System and Wastewater System services to any other property located outside of Valley Township.

3. Valley shall not amend or repeal this Resolution without providing prior written notice to the Commission.





RESOLUTION #2020-21

**A RESOLUTION OF THE VALLEY TOWNSHIP
BOARD AMENDING RESOLUTION #2020-09.**

WHEREAS, Valley Township owns and operates a (1) sanitary sewer collection and treatment system (“Wastewater System”) and (2) water treatment and distribution system (“Water System”); and

WHEREAS, in addition to the Sewer System and Water System customers who are located within the Valley Township municipal boundary, 22 additional water customers from adjacently located West Caln Township and East Fallowfield Township are tied into and being served by the Water System (“Outside Water Customers”) and 30 additional wastewater customers from adjacently located West Caln Township and East Fallowfield Township are tied into and being served by the Wastewater System “Outside Wastewater Customers” and collectively with the Outside Water Customers, “Outside Customers”);

WHEREAS, on March 30, 2020, the Township of Valley Board of Supervisors passed Resolution #2020-09 authorizing the filing of petitions for declaratory order with the Pennsylvania Public Utility Commission regarding the Outside Customers and committing to charging them the same rates as Valley customers; and

WHEREAS, it has since been determined that in 1988, Valley Township committed to providing wastewater service to additional undeveloped parcels comprising a portion of the Highlands Corporate Center located in West Caln Township.

NOW THEREFORE, BE IT AND IT IS HEREBY RESOLVED, by the Township of Valley Board of Supervisors as follows:




located outside of Valley Township other than only the portions of the Highlands Corporate Center that are located in West Caln Township, and only for purposes of wastewater service with respect to those parcels.

2. Valley shall not amend or repeal this Resolution without providing prior written notice to the Commission.






