In accordance with Paragraph 6 of the Pennsylvania Public Utility Commission's ("PUC" or the "Commission") September 22, 2020 Opinion and Order regarding the Petition of Twin Lakes Utilities, Inc. For A Commission Order Authorizing the Acquisition of Twin Lakes Utilities, Inc. By A Certified Public Utility Pursuant to 66 Pa. C.S. § 529 ("September 2020 Order"), Aqua Pennsylvania, Inc. ("Aqua") is providing a status report to the Commission's Bureau of Technical Utility Services. The Commission's September 2020 Order stated that during the ninety (90) day due diligence period Aqua "shall provide the Commission's Bureau of Technical Utility Services with regular status reports regarding its due diligence efforts".<sup>1</sup>

Aqua has completed a review of files provided by the Pennsylvania Department of Environmental Protection and conducted site visits of the Twin Lakes Utilities, Inc. system. Aqua has also reviewed information from Twin Lakes Utilities, Inc.'s 2019 base rate case and annual reports. Aqua is currently providing its review and analysis of the Twin Lakes Utilities,
