
### Petition for Reconsideration

To Whom It May Concern,

This letter is in response to the dismissal notice that I received on 11/2/2020. I intend to explain why necessary documents where not filed within the designated time period in the hopes that this commission will reverse its decision and reinstate my operating authority. Below please find a numbered outline explaining the reasons for this request.

- 1. This application was filed before the Coronavirus Pandemic had arose. I had every intention of creating and operating this company much early than my current start date (7/1/2020) but this year's events caused me to pause my plans and wait to see what was going to happen with our economy and my industry. I appreciate and thank this commission for the extra time that was allowed so I could wait to purchase insurance once I reevaluated my plans.
- 2. On 7/1/2020 I purchased liability and cargo insurance from The McCulloh Insurance Group LLC. I specifically requested that form E and H be filed with the PA PUC as required. I assumed this was done as it is a simple task and has to be done by them. My fault was in assuming this was done and not double checking. I have since contacted them to let them know my operating authority has be revoked and four months have passed without these forms being filed. For this I apologize and hope that filing these forms immediately will be acceptable because the policy has been in place since 7/1/2020.
- 3. I failed to file a tariff with the PA PUC. This was entirely my oversight and I apologize. I honestly thought the tariff needed to be kept on file in my office and was not aware that it needed to be submitted to this commission. After talking to Charles Morris with Tristate Household Goods Tariff Conference, he noted that for the FMCSA, the tariff only needs to be kept on file at our personal office but must be filed with the PA PUC. He has been of great assistance in clarifying the tariff system in PA. Upon re-approval by this commission he has assured me that the tariff will be filed correctly as I will be joining the THGTC.

Lastly, I hope that we can come to a mutually beneficial resolution. I fully realize my error in oversight and can guarantee it will not happen again. With starting a new business for the

first time, having a full-time job, family and everything else going on this year I admittedly let a few things slip. Having to refile and new application with another 90-day waiting period will be a crippling financial blow to my company. I have already had to cancel scheduled work due to my operating authority being revoked. Please let me know if there is anything I can do to assist in resolving this matter. Thank you for your time and consideration.
