Your letter of September 30, 2020 has put me in a most shocked state of confusion. This letter allows me 20 days to reply as an exception to the commission. Does "20 days" restrict it to calendar days or 5 days a week work days -- with a legal holiday of October 12, 2020?

I may be lacking in knowledge but since September 19, 2020 and a written letter in between with a judgment as made and a rough total of 366 days plus 13 days equalling 379 days with no replies made but implied, now you allow me so-called 20 days re: make responses to what? It seems to me that the "box was empty" a long-a-time ago.

Being a widower, my life-style is moving to my daughter's best. I received your September 20, 2020 letter when I travelled to my daughter's house around October 16 -- allowing me response time 4-5 days... with a doctor's appointment re: my left eye. This type of appointment has been a 13 month schedule for me in a past period with Retina & other consultants in Monroeville, Pa.

In fact my next monthly appointment is this Tuesday, October 20, 2020. (Eton and an injection in my eyeball --- and chauffeured "to and from" the city, because of driving limitations)

And my daughter's number asks me for a flight to Angel Fire, New Mexico for (c.) 5 weeks, closing about December 27-28(?) or so. I leave Pa about November 24-25(?) 2020.

As you see, being a "roaming Catholic" my schedules are not posted in future time except such as I have.

Please continue sending any mail to my daughter's house. 311 Case Avenue, Sharon, Pa. 16146, until further notice.

In closure, I leave about November 25-26 (till my flight ticket arrives) 2020.


Whatever maximum extension I may have for this exception request is unpredictable, with a lee-way if necessary, hopefully January 21, 2021
