

This filing is for a CHANGE in the application of rates (Column 1 changed to Tuesdays, Wednesdays & Thursdays - Column 2 changed to Mondays, Fridays & Saturdays - no change to Column 3). NOTE 1 - Traveling charges are in addition to hourly rates (Columns 1, 2 and 3). The travel charge to be based on actual time from carrier's terminal to first point of origin and from final destination back to carrier's terminal.

NOTE 2 - Hourly rates (Columns 1, 2 and 3) are based on the day or days, or period of days, as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 1, 2, and 3) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 6 hours at rates named in Column 3 plus applicable travel time charge. Fridays & Saturdays (any hour) or Mondays - Thursdays (any hour): 1 hour at rates named in Columns 1 or 2 plus applicable travel time charge.

▲ NOTE 5 - In lieu of rates shown in Freight Pa. P.U.C. Nos. 50-T and 51-W, the following shall apply for declared value protection: For the minimum declared value of the shipment, multiply the actual weight (or, in the case of an hourly move, the estimated weight) times \$2.25 (i.e. 5000 pounds times \$2.25 equals \$11,250.00 declared value). Cost for declared value protection is \$.30 per \$100.00 declared value (i.e. \$11,250.00 declared value times \$.30 per \$100.00 declared value equals \$33.75).
