

Pursuant to 52 Pa. Code §§ 5.103 and 5.61, Respondent Duquesne Light Company ("Duquesne Light" or the "Company"), by and through its attorney, Emily M. Farah, files this Motion to Consolidate:

1. On or about October 7, 2020 Complainant Benjamin Kroop ("Complainant") filed a formal complaint at docket number C-2020-3022330 ("Complaint No. 1") with the Pennsylvania Public Utility Commission ("PUC" or Commission") against Duquesne Light.

2. On or about December 3, 2020 Complainant filed a second formal complaint at docket number C-2020-3023135 ("Complaint No. 2") with the Commission" against Duquesne Light.

3. The Complaint No. 1 and Complaint No. 2 (collectively, "Complaints") are both associated with electric service provided to Complainant's residence, located at 233 Main Street, Pittsburgh, PA 15201 (the "Property").

4. The Complaints involve the same parties and make allegations concerning electric service to the Property.

5. In the interest of judicial economy, Duquesne Light requests the Complaints be consolidated for the purposes of mediation, discovery, and hearing, to the extent a hearing is required.

6. Consolidating the Complaints would not prejudice either party.

7. Duquesne Light Company respectfully requests the Commission consolidate the Complaints filed by the Complainant regarding electric service provided to the Property, and handle the Complaints together.

WHEREFORE, Duquesne Light Company respectfully requests that the Commission grant its Motion to Consolidate.


