

Attached are updates for 354th Page 2 and 4th Revised Page 11-H for A Action Family Moving Company, Inc., t/a Transtar Moving Systems (PA PUC #A-00113642) in Moorestown NJ. This filing is for an INCREASE in their local hourly rates (except for 1 Man rate), a REDUCTION in the travel time charge for 131 – 150 miles, and INCREASES in some of the carton & packing labor rates as noted by the symbol (◆), REDUCTIONS in the carton & packing labor rates as noted by the symbol (ⓧ), and the ADDITION of a TV carton noted by the symbol (▲). Carton prices and packing labor rates with the symbol (●) remain the same as previously filed.
