
5. It is desirable to construct a new structure over the Norfolk Southern Railroad Company north of the Southbound Lemoyne Exit. The location of the proposed ramp is near railroad milepost LG-1.28 in Lemoyne Borough, Cumberland County. The proposed structure will span over the two (2) tracks of the Norfolk Southern Railroad Company (DOT# No. 960 507 X) and will carry

one (1) through lane of traffic. A Location Map which is attached hereto and marked as Exhibit "A".

6. The anticipated average daily traffic for the SR 8513 is 9,981 vehicles with 7% trucks.
7. The estimated total cost for the construction of the SR 8513 bridge is approximately \$4.4 million. The funding for the project will be 100% state funds.
8. This project is necessary and proper for the safety and convenience of the public.
9. A conference of all parties of interest should be held to discuss the proposed alteration.



LOCATION MAP




