Dear Mr. Fogelsanger:

LTL Consultants is and has been the sanitary sewer system consultant for Upper Pottsgrove Township over the past several decades. This letter is offered as a status report on Upper Pottsgrove Township's compliance with its Act 537 Official Sewage Facilities Plan approved by the PA DEP on January 31, 2011.

Future Connections proposed in the 5-10 year time frame have been partially completed at this time. Below are the areas identified in the DEP approval letter and their status:

- The Farmington Avenue West Sewer Project Phase 2 has been completed.
- Regal Oaks Phase 2 connections have been partially completed. Remaining connections are to be undertaken by PAWC.
- The sewer extension to service Ming Drive/Moyer Road is under contract and should be completed by early 2021.
- The sewer extension to service Horseshoe and Bruce Drives will be undertaken by PAWC.
- The sewer extension to Continental and Old Orchard Drives will be undertaken by PAWC.

Douglass Township's DEP-approved Act 537 Plan was prepared in 1993 and amended in 1997. That plan only discusses an area in Douglass Township that is referred to as Phase 1, located in the southern portion of Douglass Township that does not border Upper Pottsgrove Township. In my opinion, Upper Pottsgrove Township's own Act 537 Plan and activities are in compliance with Douglass' DEP-approved Plan.
