
To Whom It May Concern:

Paragraph No. 1 of the Commissions Secretarial Letter dated November 25, 2003, directed the City of Latrobe to submit for approval detailed construction plans for lighting the area of the railroad underpasses that are involved in this proceeding.

The lighting construction plan and specifications were received March 4, 2004. The plan is identified as "Railroad Underpass Lighting Project, Contract 1/2004, For The City of Latrobe, Westmoreland County, PA," consisting of four sheets of drawings. The specifications are identified as "City of Latrobe, Railroad Underpass Lighting Project, Contract 1/2004". Commission records do not show it received any objection to the plan or specifications that were submitted.
