By Secretarial letter dated November 25, 2003, the Commission directed repair of the lighting system that illuminates the pedestrian walkways where Jefferson, Alexandria and Ligonier Streets cross below the tracks of Norfolk Southern Railway Company in the City of Latrobe, Westmoreland County.

Commission records show that all work needed to complete construction is complete and that final costs have been allocated and future maintenance responsibility assigned.
