

Attached are updates for the Exceptions Tariff, Tristate 54: 353<sup>rd</sup> Page 2, 86<sup>th</sup> Revised Page 5, Original Page 22-F, Original Page 22-F-1, and Original Page 22-F-2 for Blue Collar Movers, LLC, t/a You Move Me (PA PUC #A-8919612) in Nazareth PA. This filing is for exception pages in the Exceptions Tariff, Tristate 54, that are currently filed in an individual tariff, Freight PA. P.U.C. No. 1. This is an INCREASE in local hourly rates, overnight waiting fee, charge for taping & stretch wrapping, bulking item charges, and cost of containers & packing/unpacking labor rates. NOTE 2 - Hourly rates (Columns 2 and 3) are based on the day or days as indicated, during which services are performed.

◆ NOTE 3 - Overnight waiting (overnight storage) due to a customer delay or at the request of the customer will be billed at a flat rate of \$200.00 per night. Storage of the customer's items will be done in the vehicle used for the actual move. Vehicle will be padlocked and kept at a secure location unless carrier is otherwise directed specifically by the customer.

◆ NOTE 4 - A flat charge of \$50.00 per moving job will be charges by the carrier to cover the cost of tape and shrink wrap used while preparing furniture pieces for the moving process. This charge applies to move only jobs as supplies for jobs that include packing services are billed on a per item used basis. Individual charges for supplies used during the course of a packing or pack and move job can be found on Page 22-F-2.
