

Note 4 - Full Value Protection will be provided by carrier only if shipment is declared at a minimum lump sum of \$10,000.00 or \$3.50 for each pound of weight in the shipment, whichever is greater.

RULE 5 (B) - EXCLUSIVE USE OF A VEHICLE
